7. ☐ In lieu of automotive program completion, or ASE certifications as directed on line 5 or 6, a US military DD form 214, or certificate of training completion from any branch is acceptable. All acceptable position codes shown on page 2 are accepted.
8. ☐ Dealer candidate **must not** have previously attended an instructor led VW or Audi course.
9. ☐ Dealer and candidate understand prerequisite requirements must be completed 10 days before any ILT is started.
